

## Privacy Policy

This Privacy Policy applies to your use of <http://www.nzclearingcorp.com/> (“Site”).

In this Policy, references to “us”, “we” or “our” means NZX Limited and its subsidiaries, including New Zealand Clearing and Depository Corporation Limited, New Zealand Clearing Limited, New Zealand Depository Limited and New Zealand Depository Nominee Limited.

### Non-Personal Information

When you use the Site our server, our agent's or contractor's server logs the following information, which is provided by your browser:

- your server's IP address (a number which is unique to the machine through which you are connected to the Internet) or your personal IP address
- the type of browser and operating system you are using
- the domain name of the referring site (e.g. the previous Site that you visited).

The Server also logs:

- the date and time of your visit
- the URL address of the pages accessed and the documents downloaded.

This information does not personally identify you. We analyse this non-personal information for certain trends and statistics, such as which parts of the Site users are visiting and how long they spend there, among other possible uses.

We will not try to identify you or your browsing activities except, in the event of an investigation, where a law enforcement agency may exercise a warrant to inspect the service provider's logs or if your usage is causing technical issues for the Site which may need to be resolved. In these circumstances, we may identify your IP address to enable us to contact you.

### Personal Information

There are times when we may need personal information from you, such as your name, postal address or email address, fax and phone numbers. You will be asked to supply that personal information voluntarily. We collect personal information from applications or other forms that you submit to via the Site, from your transactions with us, our affiliates, or others, and from consumer reporting agencies. When we collect personal information on the Site, we will take reasonable steps to inform you of:

- the purpose for which the personal information is collected
- where applicable, any law that requires the particular personal information to be collected
- the main consequences for you if all, or part, of the personal information requested is not provided.

We will only use such personal information for the purpose for which you have provided it, unless you consent otherwise or they are required by law to disclose it.

We will not sell your personal information to, or share it with, any other company or third party agency, except as permitted by law. We will only disclose such personal information about you to those employees who have a need to know.

Where we receive information about your session or about you, we may use that information to conduct market research surveys, for statistical analysis to determine Site usage, to run competitions and for direct marketing purposes relating to our business, to tailor our services to match your needs and improve the Site generally. We will ask you when you provide personal information whether you wish to receive correspondence and information from us. This will generally be by way of an 'opt-out' box that will appear each time you are asked to provide personal information for additional purposes. Please tick this 'opt-out' box if you do not wish your personal information to be used in this way. We do not collect sensitive information such as your racial or ethnic origin, political opinions or religious beliefs.

We will take all reasonable steps to allow you access to your personal information and we will correct personal information if we are satisfied that it is incorrect.
